Expeditions are generally limited to 12 people on a first come, first served basis. Payment may be made by check. To reserve space on a *Dunrovin Ranch Expedition*, a non refundable \$500 per person deposit is required for trips that are nine days or less, and a non refundable \$750 deposit is required for trips that are ten days or more. Final payment must be made at least 90 days before the start of the expedition.

## **Terms and Conditions**

### **Responsibility**

Dunrovin Ranch acts only as an agent for any transportation carrier, hotel, ground operator, or other suppliers of services connected with these expeditions ("other providers"), and the other providers are solely responsible and liable for providing their respective services. The passenger tickets in use by the carriers shall constitute the sole contract between the carriers and the passenger; the carriers are not responsible for any act, omission, or event during the time participants are not aboard their conveyances.

Dunrovin Ranch shall not be held liable for (A) any damage to, or loss of property or injury to, or death of, persons occasioned directly or indirectly by an act or omission of any other provider, including but not limited to any defect in any aircraft, or vehicle operated or provided by such other provider; and (B) any loss or damage due to delay, cancellation, or disruption in any manner caused by the laws, regulations, acts or failures to act, demands, orders, or interpositions of any government or any subdivision or agent thereof, or by acts of God, strikes, fire, flood, war, rebellion, terrorism, insurrection, sickness, quarantine, epidemics, theft, or any other cause(s) beyond their control. The participant waives any claim against Dunrovin Ranch for any such loss, damage, injury, or death.

Dunrovin Ranch shall not be held responsible for any damages associated with damage to, or loss of property or injury to, or death of, persons occasioned by use of horses during the expedition. Dunrovin Ranch shall not be held liable if a horse may, without warning or any apparent cause, buck, stumble, fall, rear, bite, kick, run, make unpredictable movements, spook, jump obstacles, step on a person's feet, push or shove a person, all of which may cause the rider to fall or be jolted, resulting in serious injury or death. By registering for a Dunrovin Ranch expedition involving horses the participant acknowledges that horses may behave unpredictably and irrationally, regardless of their training and past performance and that horseback riding is a dangerous activity involving risks of physical harm to horse, rider, spectator, or pet. By registering for a Dunrovin Ranch expedition, participant acknowledges that horseback riding in Montana's back country is especially dangerous because of uncontrollable conditions presented in back country situations, including but not limited to weather, terrain, other animals, and the distance from emergency medical services. Participant agrees to release Dunrovin Ranch from any claims of negligence, loss, liability, damage, or injury (including death) arising out of or in any way connected with activities conducted during a Dunrovin Ranch expedition, including but not limited to those arising out of participant's riding experience or ability; training or selection of horses; care, fit or adjustment of saddles or bridles; horseback riding instruction; or aiding and supervising riders. To minimize risks as much as possible, by registering for a Dunrovin Ranch expedition, participant agrees to abide by and follow any instructions given or rules established by Dunrovin Ranch. By registering for a Dunrovin Ranch expedition, participant agrees that the foregoing agreements of responsibility for assuming risks and release and indemnity of releases is intended to be as broad and inclusive as permitted, and that if any portion of this agreement is determined to be invalid, illegal, or unenforceable, the validity, legality and enforceability of the balance of the terms and conditions shall not be affected or impaired in any way and shall continue in full legal force and effect. By registering for a Dunrovin Ranch expedition, participant agrees that if he/she files a lawsuit on behalf of himself/herself, his/her minor children, or on behalf of anyone else, he/she will pay all attorney's fees and costs incurred by Dunrovin Ranch, and their employees or agents in defending against such action. Dunrovin Ranch shall not be held liable for any loss or damage due to delay, cancellation, or disruption in any manner caused by a horse becoming ill. By registering for a Dunrovin Ranch expedition, participant assumes the unavoidable risks and dangers inherent in all horse related activities.

By registering for a Dunrovin Ranch expedition, the participant certifies that he/she does not have any mental, physical, or other condition or disability that would create a hazard for himself/herself or other participants. Dunrovin Ranch reserves the right in their sole discretion to accept, decline to accept, or remove any participant on a Dunrovin Ranch expedition. Dunrovin Ranch reserves the right, without penalty, to make changes in the published itinerary whenever, in their judgment, conditions warrant, or if they deem it necessary for the comfort, convenience, or safety of participants.

Dunrovin Ranch shall not be liable for any air carrier's cancellation penalty incurred by the purchase of a nonrefundable ticket to or from the participant's Dunrovin Ranch departure city. Baggage and personal effects are at all times the sole responsibility of the participant.

### **Terms and Conditions**

**Basis of Rates:** All prices are based on two or more persons sharing a room or cabin. All prices and fares are quoted in U.S. dollars. The rates are based on current tariffs and are subject to change due to unforeseen circumstances. While we will do everything possible to maintain the listed prices, if it is necessary to levy a surcharge, we reserve the right to do so, and notification will be given at the time of final invoicing.

**Eligibility:** Anyone under 18 must be accompanied by a parent or guardian for the entire journey. For family expeditions, children must be the minimum age indicated in the trip itinerary.

**Included in Expedition Cost:** Accommodations and meals as indicated in the itinerary (B = breakfast, L = lunch, D = dinner); educational materials; pre-departure information; entrance fees, excursions, and sightseeing noted as included in the itinerary; all gratuities except those for lodging staff, unless otherwise noted on the itinerary page; ground transportation during the expedition; transfers to and from group flights where applicable; services of Dunrovin Ranch experts, lecturers, guides, expedition manager, and any other staff; taxes, port charges, baggage handling, and service

charges. Please note: The "B, L, D" notations only apply to the period during the expedition and do not include any meals on flights to/from the trip. Internal airfare is included on some international expeditions as indicated in the itinerary.

**Not Included:** Air transportation and related fees (except as indicated in the itinerary); activities noted as optional in the itinerary; gratuities for train or ship's crew, unless otherwise noted on the itinerary page; passport and visa expenses; baggage/accident/cancellation insurance; personal expenses, such as laundry, telephone calls, and alcoholic beverages; and any other items not specifically noted as included.

**Single/Shared Accommodations:** A limited number of single rooms/cabins may be available at extra cost on a first-come, first-served basis. We will assist persons requesting a roommate. Participants will be notified if a suitable roommate is not available, in which case the single rate will be charged.

**Payments, Cancellations, and Refunds:** To reserve space on a Dunrovin Ranch expedition, a \$500 per person deposit is required for trips that are nine days or less, and a \$750 deposit is required for trips that are ten days or more.

**For trips departing in 2008,** final payment is due no later than 90 days prior to departure. Dunrovin Ranch reserves the right to cancel a reservation if full payment has not been received by 90 days prior to departure. For reservations made within 90 days of the departure date, full payment is required when the reservation is accepted. All cancellation notices must be received in writing and will become effective as of the date of the postmark. If you cancel 120 days or more prior to departure, a refund less an administrative fee of 50% of your deposit will be made. Per person charges for cancellations that occur less than 120 days prior to departure are as follows: 91-119 days prior to departure: 100% of your deposit amount; 45-90 days prior to departure: 50% of the expedition cost; 44 or fewer days prior to departure: 100% of the expedition cost. This policy also applies to pre- and post-trip extensions. Any airline tickets issued are subject to the carrier's refund policy.

Leaving an expedition in progress, for any reason whatsoever, will not result in a refund, and no refunds will be made for any unused portions of an expedition. Dunrovin Ranch reserves the right to cancel any trip because of inadequate enrollment that makes the trip economically unfeasible to operate or because of good-faith concerns with respect to the safety, health, or welfare of the participants. If Dunrovin Ranch cancels an expedition prior to departure, you will receive a full refund of monies paid to Dunrovin Ranch, except in the event the cancellation is due to a major global event that has resulted in the cancellation of multiple trips, in which case you will receive a refund and/or credit equivalent to monies paid to Dunrovin Ranch. If we cancel the trip in progress, you will receive a prorated refund based on the number of days not completed on the expedition. We will not be responsible for any refund for nonrefundable airline tickets or for any airline tickets purchased by the passenger directly from an airline or travel agent.

**Trip cancellation insurance is available with most travel agencies or insurance companies and is strongly recommended.**

**Itinerary Changes:** The itineraries and staff presented in a trip announcement are subject to modification and change by Dunrovin Ranch. Every reasonable effort will be made to operate programs as planned, but alterations may still occur after final itineraries are sent.

**Health Requirements:** You must be in good physical and mental health. Any physical condition, diet, or treatment requiring special attention must be reported in writing when the reservation is made.

**Photography:** We reserve the right to take photographs or videos during the operation of any expedition or part thereof and to use the resulting photography for promotional purposes. By booking a reservation with Dunrovin Ranch, participants agree to allow their images to be used in such photography; participants who prefer that their image not be used are asked to identify themselves to their expedition manager at the commencement of their trip.

**Other:** Additional Terms and Conditions may apply to some expeditions and will be provided with pre-trip mailings.

By registering for a Dunrovin Ranch expedition, the participant agrees to the Responsibility statement and the Terms and Conditions herein, and is willing to sign a liability release form at the start of the expedition.
